## 3. Requisite Qualification:

- Should possess/acquire BE/B.Tech from a recognized University/Institution (Recognized by AICTE or State Govt./Central Govt.) in applicable branches.
- Should possess/acquire 3 year Diploma from a Polytechnic College/Institution recognized by the State Govt./Central Govt. in applicable branches.

## 4. Eligibility Criteria:

- The candidate should have B.E./B.Tech Degree/Diploma certificate or Provisional B.E./B.Tech Degree/Diploma Certificate in applicable branches.
- The candidate should have scored minimum passing marks and obtained a Degree/Diploma Engineering in the year 2018, 2019 and 2020. (Students passed after July 2018 only are eligible to apply).

- The candidates who have already undergone or are currently undergoing apprenticeship training under Apprenticeship Act 1961, and/or having one year work experience are not eligible to apply.
