Applications are invited from qualified and eligible candidates (Graduate & Diploma holders in Engineering) belonging to Karnataka state through online mode for undergoing One year Apprenticeship training under the Apprenticeship Act 1961 for the year **2021-22** in **Hubli Electricity Supply Company Limited** as given below:

1. Requirement

2. Requisite Qualification:

- Should possess/ acquire B.E./ B.Tech from a recognized University /Institution (Recognized by AICTE or State Govt. / Central Govt.) in applicable branches for Graduate apprentices.
- Should possess/ acquire 3 year Diploma from a Polytechnic College/ Institution recognized by the State Govt./ Central Govt. in applicable branches for Technician (Diploma) Apprentices.

3. Eligibility Criteria:

- The candidate should have B.E. / B. Tech Degree / Diploma certificate or Provisional B.E. B.Tech Degree / Diploma Certificate in applicable branches.
- The candidates should have scored minimum passing marks and obtained a Degree/Diploma Engineering in the year **2019, 2020, 2021.**
- The candidates who have already undergone or are currently undergoing apprenticeship training under Apprenticeship Act 1961, and / or having one-year work experience are not eligible to apply.
- Age limit Age limit will be followed as per Apprenticeship Rules.

4. Reservation:

Guidelines under Apprentices Act on Reservation for SC/ST/OBC/PWD will be followed. Those who are claiming reservation under SC/ST/OBC/PWD shall provide certificate as per Government standard format, failing which their claim for reservation will be considered under 'General' category only. If BC candidates claiming OBC category, they should bring OBC certificate as per the Govt. prescribed (OBC) format from the certificate issuing authority.

5. MINIMUM PHYSICAL STANDARDS:

As prescribed in Clause 4 of the Apprenticeship Rule 1992, and amendments thereof if any.

6. DURATION OF TRAINING:

The duration of Apprenticeship training will be for a period of one year as per Apprenticeship Act 1961.

7. SELECTION PROCEDURE:

Board of Apprenticeship Training (Southern Region) is entrusted with the task of short-listing the candidates from online application data. Short listing process will be done based on the marks secured in the Qualifying examinations only. Short listed candidates will be intimated through their registered Email ID's only. They will have to appear in person for verification of documents at the **O/o Executive Engineer (Ele.), ITI, HESCOM, Karwar Road, Vidyut Nagar, Hubballi.**


